**Financial Requirements**  
**Mother Seton Remedial Program**

Tuition and Building Fund is payable through FACTS Management Company. Once the account has been registered online at <https://online.factsmgmt.com/signin/3TMYR>, you may choose either the 5<sup>th</sup> or the 20<sup>th</sup> of each month as your payment date beginning in July. Automatic payments can be made from checking/savings account or from a variety of credit cards. All obligatory fees will be paid in the school office. Returned checks will be assessed a \$25.00 service charge and entire amount owed must be paid with cash, cashier's check, or money order.

**Tuition Rates**
